SUMMARY

- The Offer Price has been determined at HK\$0.34 per Offer Share (exclusive of brokerage of 1%, SFC transaction levy of 0.0027% and Stock Exchange trading fee of 0.005%).
- Based on the Offer Price of HK\$0.34 per Offer Share and 437,600,000 Offer Shares comprising 197,600,000 New Shares offered by the Company for subscription and 240,000,000 Sale Shares offered by the Selling Shareholder for sale, the net proceeds from the Share Offer to be received by the Company, after deducting the underwriting commissions and estimated expenses payable by the Company in relation to the Share Offer, is estimated to be approximately HK\$55.4 million. The Company intends to apply such net proceeds in accordance with the purposes set out in the section headed “Future plans and use of proceeds” of the Prospectus.
- The Public Offer Shares initially offered under the Public Offer have been very significantly over-subscribed. A total of 4,434 valid applications have been received pursuant to the Public Offer on **WHITE** and **YELLOW** Application Forms and through giving **electronic application instructions** to HKSCC via CCASS for a total of 922,340,000 Public Offer Shares, representing approximately 21 times of the total number of 43,760,000 Public Offer Shares initially available for subscription under the Public Offer.
- Out of the 4,434 valid applications for a total of 922,340,000 Public Offer Shares:
 - 4,405 valid applications for a total of 335,980,000 Offer Shares were for Public Offer Shares with an aggregate subscription amount based on the maximum Offer Price of HK\$0.34 per Offer Share (excluding brokerage of 1.0%, SFC transaction levy of 0.0027% and Stock Exchange trading fee of 0.005%) of HK\$5 million or less (equivalent to approximately 15 times of the 21,880,000 Offer Shares initially available for allocation in pool A of the Public Offer); and
